INTEGRATED URBAN WATER PLAN

THE STUDY

The City of Vaughan is developing a new Integrated Urban Water Plan to continue to meet the community's water needs for current and future generations. To help inform the project, an Integrated Urban Water Plan Environmental Assessment (EA) is underway. This includes a review of current urban water infrastructure, such as water, wastewater and stormwater systems.

The Integrated Urban Water Plan will be the City's long-term strategy for providing water, wastewater and stormwater management systems that are safe, reliable, resilient, environmentally sustainable and financially responsible.

The Integrated Urban Water Master Plan EA study evaluates servicing plans for current and future growth in Vaughan and will identify alternative servicing solutions and initiatives. As part of the assessment, existing problems will be reviewed, solutions will be considered and preferred water, wastewater and stormwater servicing strategies will be evaluated. The study will also integrate current sustainability, resiliency and climate change adaptation/mitigation initiatives identified in Green Directions Vaughan and the Official Plan Review.

THE PROCESS

The Integrated Urban Water Master Plan EA study is being conducted in accordance with the Master Planning process (Approach #2) outlined in the Municipal Engineers Association Municipal Class EA guidelines (October 2000, amended 2007, 2011 and 2015). This approach involves the preparation of a Master Plan document at the conclusion of Phase 1 and 2 of the Class EA process.

GET INVOLVED

Public input remains vital to the development of the plan. Input collected to date has helped identify concerns, solutions, environmental impacts and more. Now, as the study advances, citizens are once again encouraged to get involved.
